# About the transportation and housing program

### ABOUT THE TRANSPORTATION AND-HOUSING PROGRAM

This program covers additional costs for travel that families may have to cover for someone with a disability. The program also helps families get adapted support for their needs so that they can continue to stay involved in the life of their loved one.

## WHO THIS SERVICE IS FOR

The following clients are eligible for this program :

- School-aged children attending a recognized early childhood stimulation centre.
- Someone receiving one of the following treatments:
  - ◊ Ongoing hemodialysis.
  - Repeated and ongoing intensive medical treatments for the disability.
  - Intensive (12 treatments or more at a rate of at least once every two weeks) and ongoing rehabilitation treatment (audiology, occupational therapy, speech-language pathology, physiotherapy).

 This treatment must be delivered by a professional in the Quebec health and social services network who is a member of his or her professional order.

### ELIGIBILITIES

- Provide a diagnosis attesting to the disability or illness
- Present a situation of handicap
- Be a resident of the Laval territory

### GOALS

This program provides financial assistance for travel to anyone with an intellectual, mental, organic, or physical (motor, visual, auditory or speech-language) impairment. This reimbursement is for travel to institutions in the network of the Ministère de la Santé et des Services sociaux (MSSS) (the most appropriate and closest) that provide adaptation and rehabilitation services, diagnostic services, or treatment for the impairments listed in the person's intervention plan

#### **AVAILABLE SERVICES**

This program subsidizes a percentage of travel costs, depending on the type of transportation. Parking is also reimbursed at 60%.

### RESPONSABILITY OF THE CISSS DE LAVAL

When providing this service, the CISSS de Laval agrees to :

- Ensure that your case manager evaluates your needs and establishes your intervention plan as well as the need for other services, if necessary.
- Ensure that services are re-evaluated according to a set schedule and that your intervention plan is updated.
- Ensure that you get information about the different types of transportation you can use and how this travel is reimbursed. .
